

# 9th Annual JURIED EXHIBITION

Cash and purchase awards exceeding \$ 2,600.00 will be presented in this year's exhibition.

**First place: \$750**  
**Second place: \$500**  
**Third place: \$300**

## Eligibility/Requirements

- **ENTRY DEADLINE : 6/15/22**
- **Eligibility:** The competition is open to artists, professional or amateur, who reside in North Carolina or South Carolina.
- **Age:** Artists must be age eighteen or older.
- **Entries:** 1 or 2 original artworks may be submitted on the entry form (entry fee covers both artworks.) (ENTRY FORM)
- **Entry Fee: Early bird (May 13 - May 30): \$20.00; May 31 - June 15: \$30.00.** (This fee covers 1 or 2 entries.) Payment is required at time of submission (PayPal) or within (2) days of submission (In Person). In person payment can be made via check, money order or credit card by visiting the in the Administration Office (Monday - Friday; 10:00am - 5:00pm) at the Headquarters Library. For online payments\*\* The PayPal prompt screen will appear once all form information is submitted.\*\*
- **Eligible Work:** All work must be original and created within the past 5 years and not previously shown at the library. All work must be “exhibition ready”. Because the Spartanburg County Public Libraries are open to the public, we cannot display any nudity, violence, or graphic language/actions in the works that are entered. The Spartanburg County Public Libraries reserve the right to refuse any submission that it deems unacceptable for the exhibition. These works may be in any 2-D media (or works with the ability to be hung on a wall) including painting, drawing, photography, fiber, printmaking, illustration, mixed media, etc.
- All works to be hung must be framed and securely wired or be fitted with two d-rings. If subject to damage, the artwork must be framed under Plexiglass (no glass will be permitted); securely wired stretched canvas is also acceptable. **No clip mounting will be accepted.** If works are not adequately prepared for display, they will be withdrawn from the exhibition.
- **Size Limitations:** Size restrictions are 40” wide x 60” length.
- **Commission:** All work available for sale will have a 20% commission fee taken if the work is sold to benefit the Library and future exhibitions.

- **Submitting Images:** Must be in JPEG format, at least 1 MB in size but not exceed 4 MB – please label each image with your last name/first initial and title (JSmith\_Flowers.jpg). (ENTRY FORM)
- **Agreement of Terms:** Artists must accept terms of an Agreement for Exhibition document shown below. Your submission into the competition will indicate your automatic agreement to the terms.
- **Liability:** The Spartanburg County Public Libraries will not assume responsibility for loss or damage of works while on exhibit. We reserve the right to refuse any entry and to withdraw any work from the exhibition at our discretion. The Spartanburg County Public Libraries reserve the right to photograph and reproduce any entry submitted for educational, informational or publicity purposes. The receipt of an entry in the exhibit will constitute agreement by the artist with all conditions set forth in this prospectus.
- **Notification:** Acceptance/rejection notification will be sent via email to all entrants by July 7, 2022.
- **Accepted Artwork:** All accepted work must be properly framed or gallery wrapped (canvas stretches around the stretcher frame to create a clean, professional appearance), and wired for hanging. No exceptions will be made! Failure to present work in this fashion can mean disqualification. Accepted artwork must have the following info attached directly to the artwork: **Artist Name, Address, Phone, Email, Title, Medium, Price, and year completed.** Accepted artwork must be delivered to the Marketing Office on the main level of the Headquarters Library **August 1 - 4 (10:00am - 4:00pm).**
